maurices "12 Days of Merry" SweepstakesOfficial Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT WILL NOT INCREASE OR IMPROVE YOUR CHANCES OF WINNING.

- 1. **ELIGIBILITY.** The maurices "12 Days of Merry" Sweepstakes (the "Sweepstakes") is open only to entrants who, as of the entry date, are permanent legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years of age. The Sweepstakes is void outside the eligible Sweepstakes territory, and where prohibited or restricted by law. Sponsor's computer is the official timekeeping device for the Sweepstakes.
- **3. HOW TO ENTER.** There is one (1) way to enter. During an Entry Period, visit www.maurices.com/giveaway and enter your name andemail to enter. A valid email address is required for entry. YOUR ENTRY MUST MEET THE REQUIREMENTS.

- **4. The prize(s) (except for number 12) will be distributed by sending each winner in this Sweepstakes the respective prize won for that Entry Period via USPS, UPS, FedEx, or a similar postal courier. The electronic gift card will be sent to each winner via email. The electronic gift card is subject to the terms, conditions, limitations, and restrictions of the issuer thereof.

The ARV of each prize shown above ranges from approximately \$124.50 to \$599.50, and the aggregate ARV of all prizes tobe awarded in this Sweepstakes is \$3,204.00.
